Commentary⁴

Equity markets were weak in March as concerns around US tariff policy, slowing growth and stubborn inflation increased. The "Magnificent 7" and other technology names were notably weak; the "Magnificent 7" falling by over 10% and the Nasdaq by over 8%. Europe was more resilient, driven by German fiscal and defence spending plans, with the Euro Stoxx 50 down 3.9% while the Hang Seng was a rare area of stability, +0.8% on the month. Credit was wider, iTraxx Crossover in Europe by 39bps. Government yields were generally stable, though German yields nudged higher on defence and other spending plans, the five-year yield rising by nearly 20bps to ~2.3%. Convertible markets were resilient in the face of such equity market weakness, the Global Focus Index (USD hedged) falling 1.36%.

Convertible issuance rebounded strongly as \$13.3bn of new supply came to market. The US led supply with \$8.2bn, but other regions also saw meaningful issuance with Asia bringing \$3.7bn and Europe \$1.4bn. The range of deals spanned various sectors and structures including mandatories, exchangeables and green deals.

The Fund's European portfolio made gains on the month, while the US and Asian portfolios both detracted. The strongest sector by some distance was Industrials with Utilities also positive. Information Technology, Consumer Discretionary and Financials holdings detracted. On a single name basis, German defence group Rheinmettal contributed most, followed by French engineering concern Spie and Iberdrola. The largest detractor was US Fintech name Sofi on economic slowdown fears. Jetblue Airways was weak on downbeat US airline sector updates and Schneider Electric retraced some recent gains.

The Fund received meaningful inflows of capital in the month which was deployed in both the primary and secondary markets. The Fund participated actively in the primary market with new deals from Fresenius exchangeable into Fresenius Medical, Iberdrola and Baidu exchangeable into Trip.com. The Fund made a range of secondary market purchases across geographies and sectors including property, industrials, utilities and software, scaling up existing positions. The Fund exited some positions ahead of maturity, including Amadeus 1.5% 2025 and BNP 0% 2025. The Fund sold Jet2 1.625% 2026 into repurchase by the company, put its position in Euronet Worldwide 0.75% bonds and sold Arcadium Lithium 4.125% 2025 on takeover.

We continue to anticipate larger market swings and volatility across all asset classes as tariff policies and their effects roll through global economies and markets. In this febrile investment environment, with equities weak and volatile, and credit spreads widening, we continue to focus on convertibles which we believe combine reasonable valuations, solid credit metrics and downside protection and with upside potential.

The Fund retains a weighted average credit rating of BBB+, which combined with the portfolio's short duration, should mitigate the impact of widening in credit spreads. Greater moves in equity markets and dispersion in individual equities can benefit the Fund in the medium-term. Weakness in markets will present the opportunity to rotate the portfolio to more balanced securities to retain asymmetry and capture possible future upside. In short, we believe the Fund is well placed for relative returns in less favourable market conditions, while maintaining upside optionality should economies and markets develop more positively in the longer-term.
